**6. GENERAL TERMS & CONDITIONS:**

- i. The engagement of all Gatka coaches/instructors would be on purely temporary and on contractual basis for a period of 12 months, subject to the satisfactory performance, at the sole discretion of the NGAI. Any claim for absorption at the regular position in the Academy/Centre will not be entertained at any point of time. The period of contractual can be extended with the acknowledgement of the Khelo India, Sports Authority of India, Ministry of Youth Affairs & Sports, Govt. of India.
- ii. The Gatka coaches/instructors shall be eligible of 10 days of casual leave in a calendar year. This leave will not be carried forward in case the engagement period is extended in this Academy/Centre on behalf of NGAI. Also no payment in lieu of unutilized leave will be paid by the NGAI at the time of expiry of contract.
- iii. The NGAI may terminate the services of the Coaches/Instructors in case he/she violates the written undertaking, indulgence in any unlawful activity or otherwise or unable to perform his/her duty to the satisfaction in connection with the final reports submitted by the respective State Academy/Centre in this regard.
- iv. The NGAI reserves the right to terminate the services of the Coaches/Instructors at any time without giving any prior notice and also without assigning any reason in connection with the final reports submitted by the respective State Academy/Centre in this regard.

- v. No TA/DA and any other allowances shall be admissible to the Coaches/Instructors.
- vi. Any resultant dispute shall be settled within the jurisdiction of the State.
- vii. All Coaches/Instructors have to follow the rules and regulations of the NGAI during their services as temporary coach/instructor. Detailed terms and conditions for working conditions may be issued separately along with job offer letters.
- viii. Any Coach/Instructor decides to quit the job, one month prior written notice must be served else he/she have to deposit one month salary to the NGAI if resigning without such notice.
- ix. No request for transfer to any particular place during the contract period will be entertained.
- x. The engagements of coaches/instructors on contract basis will not confer on them any right for absorption or appointment on regular basis in SAI/NGAI or concerned Academy/Centre.
- xi. Application received after due date/through post/e-mail or without supporting documents by applicants are liable to be summarily rejected.
- xii. Soliciting, influencing or trying to use outside resources to influence the hiring decision or canvassing in any form during any stage of the recruitment process will lead to disqualification/cancellation of candidature and debarred from all future interviews/opportunities.
- xiii. The candidate should report at the place of interview well in advance of reporting time.
- xiv. No request for change in date of interview and place will be entertained.
- xv. Those candidates who are called for interview will be required to produce all original certificates, failing which they will be disqualified.
- xvi. Do not bring any mobile phone etc. inside the interview hall.
- xvii. The candidates are advised to put their signatures at the time of interview exactly in the same way as signed in the application form.
- xviii. NGAI reserves the right to cancel/modify/alter the recruitment/selection process, if need arises, without issuing any further notice or assigning any reason thereof.
