## TO WHOM IT MAY CONCERN

Subject: **Fixing of honorarium/payment/fare/fee for Gatka officials and players/teams(s)**

It is informed hereby to all concerned through this official letter that honorarium/payment/fare is fixed to be paid to all the registered Gatka officials (referees, coaches and technical assistants) and registered players/teams, affiliated to the NGAI or World Gatka Federation, while performing their duties from time to time during Gatka tournaments/coaching in educational/religious institutions or providing their services/playing during Nagar Kirtans or Gatka demonstrations etc. or any other functions. Following are the fixed honorarium/payments/fares to which all concerned and organizers shall abide by.

### A. STATE/NATIONAL LEVEL TOURNAMENTS (FOR OFFICIALS)

- i. **Within the State** : Rs. 1,200/day and ordinary bus fare.
- ii. **Out of State** : Rs. 1,500/day and deluxe bus fare or second class AC sleeper train fare.
- iii. **Comfortable accommodation and meals** by concerned tournament organizers/Association

### B. DISTRICT/BLOCK LEVEL TOURNAMENTS (FOR OFFICIALS)

- i. Rs. 800/day and ordinary bus fare
- ii. **Comfortable accommodation and meals** by concerned tournament organizers/Association

### C. FARE FOR PLAYERS/TEAM(S) FOR OFFICIAL TOURNAMENTS

- i. **Within State/District** : No fare. If the organizers wish to give any fare then they can provide.
- ii. **Outside the State** : Deluxe bus fare or second class AC train fare to be given by concerned State Gatka Association during national level tournaments.
- iii. **Comfortable accommodation and meals** by concerned tournament organizers/Association

### D. COACHING/TRAINING IN EDUCATIONAL/RELIGIOUS/GOVERNMENT INSTITUTIONS

- i. **Within the district**: Rs. 300/day
- ii. **Out of district**: Rs.500/day
- iii. **Out of State** : Rs. 1,000/day and deluxe bus fare or second class AC sleeper train fare.
- iv. **Comfortable accommodation and meals** by concerned Associations/organizers

### E. GATKA DEMONSTRATIONS DURING EVENTS/NAGAR KIRTANS BY OFFICIALS/PLAYERS/TEAM(S)

- i. **Within the district** : Rs. 7,500/day
- ii. **Out of district** : Rs. 11,000/day/Gatka demonstration
- iii. **Out of State**: Rs. 21,000 per day and deluxe bus fare or second class AC train fare.
- iv. **Comfortable accommodation and meals** by concerned Associations/organizers

**It is also clarified here that ;**

1. Apart from the above honorarium/payment/fare, no other demand shall be made by the Gatka officials/players/team(s) from event/tournament organizers but if the organizers wish to give something else, they can pay more than the prescribed fee/allowance.
2. All Gatka officials/players/team(s) shall play or perform demonstration according to the prescribed Gatka Rules and Regulations of NGAI. Strict action shall be taken against those officials/players/team(s) under the Section 3B 3.7 and Section 9 sub-section 9.8.1 of Rules Book if received any complaint or found exhibiting Stuntbazi or Bazigiri during any event/tournament.
3. Disciplinary action shall be initiated against the concerned officials/players/team(s) or team manager/coach in accordance with the prevailing code of conduct on the basis of any written complaint if received by the NGAI/State Association regarding demanding over and above the fixed honorarium/fee/payment/fare or raising any other demand.
4. In case of any misbehavior found with innocent Gatka officials/players/team(s) or team manager/coach by the event/tournament organizers, a strict action shall be taken after receiving a written complaint from suffers and guilty organizers/association will be blacklisted in the future.
5. The concerned organizers should pay the fixed honorarium/payment/fare etc. daily at the end of the event and issue a written receipt of the paid amount to the Gatka officials/players/team(s) at the time of payment and keep a record of that receipt as an evidence and must be signed by the concerned players/team(s).
6. Gatka Associations shall only play the role of arbitrator in case of a bilateral dispute between Gatka officials/players/team(s). The above fixed honorarium/payment/fare/fee shall be applicable for two years from 1st April 2021 to 31st March 2023 and be revised after every two years therein enhancing it at least 10 percent.

**Note:** Managers/associations/educational/religious or Government institutions can hire the Gatka officials/players in their institutions as permanent or sign long term contracts with them and shall decide their per day honorary allowance/fees/fares by mutual consultation provided that no financial loss occurs to concerned Gatka officials/players/team(s) out of such employment/contract.
